#### Approval of Agenda

## Presentation - Vanessa Gray and Jason Richard

Mayor Nicklin and Deputy Mayor Smith met with Jason Richard and spoke about a new Home Hardware Store being built in the future. Mr. Richard and Ms. Gray had sent in a proposal which will be sent out so council can have a look at it and will be discussed and voted upon at the next meeting.

## <u>Presentation – Colleen Mooren</u>

Ms. Mooren would like to rent space in the Municipality. She is proposing moving to the Museum and condensing the space currently being used by the Museum. She suggested setting museum items out on a rotational basis so the same artifacts would not be on display all the time. There is a washroom and running water in the museum. She stated she would help man the museum year-round and also look after her business. She has been in the floral business 30 years, and she would like to open up a flower shop and gift shop in this space. She would like to sell pastries and have a courtyard and a couple of tables inside for coffee and tea.

The Caboose could be used for local artists, and this would draw more people to Main Street. It was suggested that she try to get funding from CN. She is looking at a timeline of October/November taking into account the renovations that would need to be done. The windows and roof are fairly new. Council will discuss and CAO would work the numbers and see what to charge for rent.
