#### Recreation Business Plan - Dillon and Brooke Cleghorn

Mr. Cleghorn is looking at setting up a recreational outlet with mini-golf, paintball and go-carts. He is looking at property beside the government garage in Coal Creek. He believes it is a great opportunity because of the growth in the community.

He has been in contact with recreational campgrounds in the area and they bring in an additional 2500 people in the summertime.

They are looking for any guidance the Municipality can give them. Alyson contacted CRSC and it is a free zone so there is no rezoning required for septic. They need to keep in mind that it is seasonal business so they will need to think of ideas to draw people in on their off-season and have other things available.

They need a solid business plan. They will need funding and look into government grants such as Southwest Valley. They could promote it as a center for team building exercises. They may also want to look at archery and axe throwing.

Councillor Richardson is going to try to set up a meeting for them with the Grand Lake Advisory Committee for April.
